PURPOSE:

ICON has identified that the ELT GPS Connector, D915XP, may have been pinned incorrectly. This can drain the ELT battery, which may prevent the ELT from functioning. This may be recognized by a failed self-test, a red light flashing on the remote panel, and/or audible squelching from the overhead speaker.

While a solution for the wire harness is determined, the immediate risk can be mitigated by disconnecting the faulty connector. The GPT support is designed to enhance the accuracy of the ELT signal; disconnecting it will not provent the ELT from functioning. Once it has been disconnected, performing an ELT self-test prior to each flight will determine whether the ELT battery is still sufficiently charged.

If the self-test fails, the aircraft may still be ferried to a service center, but extra caution should be taken as the ELT may not function properly in an emergency.

- 2. Access the ELT in accordance with the Aircraft Maintenance Manual, task 100293. If desired, the Instrument Panel Top may also be removed in accordance with task 100514.
- 3. Disconnect the D9157P connector (ref. Figure 1) and wrap each end with F4 Tape.

- 4. Secure the connectors to adjacent harmes as needed using TY24MX zip ties.
- 5. Reinstall the Instrument Panel Top (Arcraft Maintenance Manual task 100350) and/or the ELT Access Panel.
- 6. Complete the ELT self-test in accordance with the Aircraft Maintenance Manual, task 100139.
 - a. If the ELT battery is low, eplace it in accordance with the Aircraft Maintenance Manual, task 100019.

Make the following look entry:

"The corrective action of Safety Directive/Alert SD-111324-A (ELT GPS Connector Wiring (Interim)) has been complied with (Nof. FAA Exemption 10829D)".

For aircraft registered outside the U.S., omit "(ref. FAA Exemption 10829D)".

PRIOR TO EACH FLIGHT

1. Complete the ELT self-test in accordance with the Aircraft Maintenance Manual, task 100139. Do not fly the aircraft if the battery fails the self-test, except to ferry it to a service provider in accordance with FAR 91.207(e) (or equivalent local regulations for aircraft outside the U.S.)
